## Practice

## Recent Cases

*Hamilton v Ferguson Transport (Spean Bridge) Ltd; Thomson v Dennis Thomson Builders Ltd* 2012 S.C. 486; 2012 S.L.T. 715; 2012 S.C.L.R. 707; 2012 Rep. L.R. 79

A landmark case on whether awards in fatal cases were excessive that changed the procedure for jury trials so that guidance now given to juries as to the potential range of awards.

*Wylie v Omniasig SA* 2013 SLT 46

Road traffic accident in Romania - on the issue of the applicability of law - whether Romanian or Scots law - and the assessment of damages under Romanian law.

*Paterson v Paterson* 2013 Rep. L.R. 13

Pursuer with a severe ankle injury continued in pre accident employment. Loss of employability – the basis for such awards considered in detail by Lord Woolman. Services awarded for (the first time) to the pursuer’s girlfriend even though not living together at the time of the accident.

*Jackson v Murray* 2013 SLT 153

Appeal against finding of 90% contributory negligence in a pedestrian road traffic accident involving a 13 year old schoolgirl with multiple injuries. Overturned decision – finding was too high and substituted a figure of 70%.

*Winn-Pope v CKD Galbraith LLP* 2012 SLT 929; 2012 Rep. L.R. 126

Fall from a roof involving the Work at Height Regulations and the issue of control.
